**2010 ASHA Futurity Nomination Form**

All horses must have an ASHA Competition License and all riders and owners must be current ASHA members.

Horse/Rider combinations MUST BE NOMINATED for the futurity BEFORE showing in an ASHA show if they wish the show to count towards nomination fee credits for the futurity. After nomination fees are paid, shows participated in will count as credits toward the final Futurity Nomination Fee. Refer to ASHA Futurity Nomination Fees Below.

**3 year old horses shown in all four classes in any 2010 ASHA shows prior to May 1 will be grandfathered in if a Futurity Nomination is paid by May 1, 2010. Nominations will also be accepted through out the year for other 3 year old horses, but shows prior to May 1 will only be accredited if nominations are received by May 1.**

**100% of all Futurity Nominations will be PAID BACK to Contestants**
