Clinic Topics

Stock Horse Pleasure: The stock horse should be always under control and exhibit a willingness to respond to the rider.

Stock Horse Versatility: The stock horse should willingly undertake obstacles commonly found in a ranch setting.

Stock Horse Reining: The stock horse should be able to perform the fundamental maneuvers including lead changes, spins, rollbacks, speed control, and stops in a controlled, willing manner.

Working Cowhorse: The stock horse should be able to control a cow in a safe, controlled, willing manner in response to the rider's cues.
