#### **GENERAL SHOW INFORMATION:**

All Colorado State Fair General Rules & Terms and Conditions, the CSF Competition and Entry Requirements, & American Stock Horse Association rules shall apply. Each exhibitor is required to read all of the Colorado State Fair General Rules & Terms and Conditions as well as, the Colorado State Fair Competition and Entry Requirements prior to sending in entry forms. Exhibitors in the ASHA show must be a CoWN-SH/ASHA member if not you may purchase membership at show.

ASHA All-Around Paybacks: Exhibitors in all four classes will be eligible for the All- Around payback (\$600 Added Money plus 20% of entry fee). The Added money will be divided up among the 6 divisions; therefore, each division will have \$100 added to its' pot. The All-Around paybacks in each Division will pay only to exhibitors showing in all four ASHA Classes. The All-Around paybacks will be figured on the total number of entries in each Division. Payout Scale: 1-3 exhibitors pays 1 – 100%, 4-7 exh. Pays 2-60%, 40%; 8-11 exh. Pays 3 – 50%, 30%, 20%; 12-15 exh. Pays 4 – 40%, 30%, 20 %, 10%; 16 & over exh. Pays 5 – 30%, 25%, 20%, 15%, 10%.

**Entry Information**: All exhibitors must be a current member of the American Stock Horse Association and have an ASHA Competition License to compete. Entry forms must include copies of both membership and competition license. All Non-Pro and Open exhibitors and owners must be current members of ASHA to receive Merit Awards. You can purchase membership cards and Horse Licenses at the show for ASHA.

Late entries will be accepted with a \$50.00 late fee per horse entered. Entry fee reflects payment for any or all divisions you want to enter.

<u>Awards:</u> High Point and Reserve High Point awards in each division. ASHA Exhibitors must enter all 4 classes in order to be eligible for the All-Around payback money. You must enter all 4 classes to be eligible for the All-Around awards in the ASHA show. Exhibitors entering in separate classes and not all 4 classes will only be eligible for ribbons in each class entered.

<u>ASHA Clinic</u> – Open to 30 riders only, cost is 50.00/rider. There will be 3 clinicians to go over cattle work, rein work, and trail. Be sure to sign up online in order to get into the clinic. Once spots get filled we will close down the online form. Clinic will start at 10am on August 25, 2014.
