Equine Event Liability Release

In consideration for the State Fair of Texas permitting me to participate and perform in an equine event at Fair Park, Dallas, Dallas County Texas, I hereby agree to release, discharge and hold harmless the State Fair of Texas, the competition management, the City of Dallas, their respective agents, owners, officers, directors, volunteers, employees, and all other persons or entities acting in any capacity on their behalf, as well as the other participants and all spectators (collectively, the "Releasees"), on behalf of myself, my children, my parents, my heirs, assigns, personal representative and estate as follows:

1. I acknowledge that participating in the equine events, horse shows, riding horses and/or cow work demonstrations (the "Performance") entails known and unanticipated risks which could result in physical or emotional injury, paralysis, death, or damage to myself, property, or to third parties. I understand that such risks simply cannot be eliminated without jeopardizing the essential qualities of the Performance. I expressly agree and promise to accept and assume all of the risks existing in the Performance. My participation in the Performance is purely voluntary, and I elect to participate in spite of the risks.

2. I HEREBY RELEASE, WAIVE, DISCHARGE AND COVENANT NOT TO SUE RELEASEES, FROM ALL LIABILITY TO ME, MY PERSONAL REPRESENTATIVES, ASSIGNS, HEIRS, AND NEXT OF KIN FOR ANY AND ALL LOSSES OR DAMAGES, AND ANY CLAIMS OR DEMANDS THEREFORE ON ACCOUNT OF INJURY TO THE PERSON OR PROPERTY OR RESULTING IN MY DEATH ARISING OUT OF OR IN ANY WAY RELATED TO MY PARTICIPATION IN THE PERFORMANCE, WHETHER CAUSED BY THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE.

3. I HEREBY VOLUNTARILY RELEASE, FOREVER DISCHARGE, AND AGREE TO INDEMNIFY AND HOLD HARMLESS THE RELEASEES AND EACH OF THEM FROM ANY AND ALL CLAIMS, LOSSES, LIABILITIES, DAMAGES, DEMANDS, CAUSES OF ACTION, FEES OR COSTS THAT MAY ARISE OUT OF OR ARE IN ANY WAY CONNECTED WITH MY PARTICIPATION IN THE PERFORMANCE OR MY USE OF RELEASEE'S EQUIPMENT OR FACILITIES, WHETHER CAUSED BY THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE. I HEREBY ASSUME FULL RESPONSIBILITY FOR ANY RISK OF BODILY INJURY, DEATH, OR PROPERTY DAMAGE THAT ARISES OUT OF OR IS IN ANY WAY RELATED TO MY PARTICIPATION IN THE PERFORMANCE WHETHER CAUSED BY THE NEGLIGENCE OF RELEASEES OR OTHERWISE.

4. I grant permission to be photographed, filmed and/or interviewed in connection with the Performance and its activities. The undersigned understands that any such photographs, film or interview may be used by the Releasees for television, film, video, visual or graphic or printed media. The undersigned agrees to release and indemnify Releasees with respect to any claims related to the usage of such photographs, film or interviews by the released parties or any media.

5. Signage posted at Fair Park Livestock Facilities complies with Texas law (TX CIV PRAC & REM §87.001 – 005) and includes the following:
