

Application for ASHA Horse Competition License – version 3

ASHA requires that every horse competing in any **ASHA** approved competition be licensed with **ASHA** and that this license be shown when entering any **ASHA** approved competition. Please note, competition licenses are permanent when issued to each horse. The license is not renewed each year. A transfer procedure is required to update ownerships for horses purchased and sold. The competition license will be returned to the recorded owner listed on the papers submitted. The owner will be responsible for getting photocopies of the license to any persons needing them for entry into any ASHA approved event. Rush services are available, please contact ASHA for instructions and fees.
